David Bond is a Senior Lecturer and Director, Master of Business Analytics at the University of Technology Sydney. He has published in journals including *The British Accounting Review, Journal of Accounting and Public Policy* and *Accounting & Finance*. Joining Monash in 2007, Michaela is a highly regarded educator, with her passion and commitment to the student learning experience being formally recognised through numerous awards. Her research focuses on corporate governance, financial reporting, executive compensation and sustainability, and integrated reporting, with her work being published widely across a range of international journals. Yaowen Shan is a Professor in the Department of Accounting at the University of Technology Sydney. His research examines the role of accounting and non-accounting information in capital markets, corporate governance, and executive remuneration design. His work has been published at *The Accounting Review*, *Review of Accounting Studies, Contemporary Accounting Research, Journal of Corporate Finance, Abacus, Accounting and Finance, Pacific-Basin Finance Journal and Australian Journal of Management.* He also serves as the joint editor-in-chief of *Australian Accounting Review*, and an Associate Editor of *Accounting and Finance* and *Australian Journal of Management.* 

Yaowen's research has drawn attention from standard setters such as AASB and IASB, as well as various financial media outlets. He has secured substantial research grants exceeding one million dollars, comprising three ARC Discovery Grants and two CIFR research grants. He has also won two best paper awards at leading international accounting conferences.

Yaowen has served as an AFAANZ Board Member since 2019. In this capacity, he has co-chaired the 2020 and 2021 AFAANZ conferences and is currently serving as the treasurer on the AFAANZ Board.
