AFAANZ'S Finance SIG is holding a shark tank pitch event inviting research teams to propose a replication of an important recent finance study.

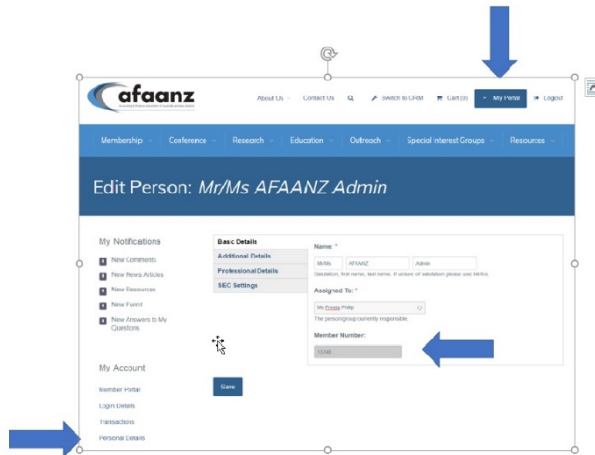
