PLENARY PAPERS

The Mid-Year Symposium features several plenary papers. Each presentation will be followed by a discussion by a discussant and Q & A from the audience. Papers accepted for plenary presentations will be considered for publication in JCAE, subject to further review and editorial approval.

Manuscripts should be submitted via the JCAE editorial manager under “Conferences”. A submission fee of US\$100 is required for plenary papers which will be refunded in the event the paper is accepted for presentation. In your letter to the editor, please state that the paper is for presentation at the 2024 Mid-year symposium. Submissions must be received no later than March 15, 2024. Authors can expect to be notified of the review outcome by May 17, 2024.
