Best Wishes to all our members for the New Year. Many of you are back at work and we wish you a successful and productive year.

Proposal to change the name of the Association

In December 2001, the AAANZ Council again unanimously endorsed

the broader strategic direction of the Association that was developed in December 2000. This direction recognises the historical and continuing productive links with the finance discipline and its rapidly expanding links with the information systems discipline. The Council decided that it was desirable to change the name of the Association to better align it with the Association's strategic direction. Accordingly, Council resolved to provide members with the opportunity to indicate, by way of ballot, their preference between two possible new names for the Association: Accounting and Finance Association of Australia and New Zealand, and Accounting Finance and Information Systems Association of Australia and New Zealand. Members also had the opportunity to express preferences for other names including 'no change'.

The Council is grateful for the considerable feedback from members concerning the proposal and will be considering the valuable feedback in its July meeting. We will keep you informed of any developments.



2002 Conference Update

AAANZ Outstanding Contribution to Education Award

This award is made every two years, and recognises the outstanding contribution to accounting education by a member of the Association. PhD Scholarships 2002

Practical experience requirements for academic staff

The Institute's Practical Experience Committee has signed off on a Log Book supplement, which lays out the competencies that must be demonstrated by accounting academic staff to satisfy the practical experience requirements for entry to the CA College. The supplement is an adaptation of the original Log Book written for practitioners.

Recruitment trends and issues

The Institute's President and Director – Admissions are touring the tertiary education institutions in 2002 to gather information on student demographics, trends and attitudes relating to the uptake of accountancy study and professional membership. Several

initiatives are likely to result from these visits aimed at attracting more students into the profession. New Zealand is currently experiencing a shortage of professional accountants and efforts need to be made to ensure an adequate supply to the profession in the future.

Relationship and interaction between academics and practitioners

A new project has been launched to explore ways in which the relationship between the accounting academic and practitioner communities can be enhanced. A range of actual and possible interactions that mutually enrich both communities has been identified.

Alternative academic entry routes for Accounting Technicians

The academic study requirements for Accounting Technicians are usually satisfied through completing a New Zealand Diploma in Business. Equivalent study (or higher) has always been considered as an alternative. However, in October last year, the Admissions Board formally approved a specific degree-level study package for entry to the College of Accounting Technicians. Formalising degree-level study requirements creates more certainty for students and allows the Institute to better promote the AT College to degree-level students who do not intend to follow through to CA College membership.

Statements of learning outcomes

The Institute has completed its project to draw up 'Statements of Learning Outcomes' (SLOs) for all required academic study topic areas. The SLOs provide guidelines for tertiary education institutions approved by the Institute

Theme: "Curriculum Design for the New Profession" Papers and presentation of workshop sessions are invited for participation in a one-day symposium to precede the Annual Conference of the Accounting Association of Australia and New Zealand (AAANZ) to be held in Perth, Western Australia.
