At the last Annual General Meeting, a decision was voted in to change the membership rates for certain categories as of 1 January 2019, as outlined below:

- The fees for Institutional and Individual members without a print copy of Accounting & Finance remain unchanged. Individual members in this category will have electronic access to the journal.
- The fee for an Individual Member with print copies of Accounting & Finance will be raised to \$155 (plus GST for Australian members). This is to cover the cost of print copies of the journal (Base membership fee of \$105 plus \$50 for print issues).
- The fee for a Student member will reduce to \$20 (plus GST for Australian members). The student will have to provide proof that they are a student.
